SECTION VII – PREVENTATIVE MEASURES

SECTION VIII – FIRST AID

Eye: Check for and remove any contact lenses. IMMEDIATELY flush with plenty of water for at least 15 minutes, keeping eyelids open. COLD water may be used. DO NOT use an eye ointment. Seek medical attention.
Skin: After contact with skin, wash immediately with plenty of water. Gently and thoroughly wash the contaminated skin with running water and non-abrasive soap. Be particularly careful to clean folds, crevices, and groin. COLD water may be used. Cover the irritated skin with an emollient. If irritation develops, get medical attention. Wash contaminated clothing before reusing.
Inhalation: Remove to fresh air. Call a doctor if irritation develops.
Ingestion: DO NOT induce vomiting. Examine the lips and mouth to ascertain whether the tissues are damaged, a possible indication that the toxic material was ingested; the absence of such signs, however, is not conclusive. If the victim is not breathing, perform mouth-to-mouth resuscitation. Seek immediate medical attention. Never give anything by mouth if victim is unconscious, is rapidly losing consciousness or is convulsing.
